Sligo Farmer of the Ninth Part WHEREAS:

1. Patrick Henry Senior of Carns aforesaid Farmer deceased prior  
to and at the date of his death was the Registered Owner in fee  
simple of ALL THAT part of the land of Carns comprised in Folio  
12358 of the Register of Freeholders County of Sligo.

Henry Junior and Joseph Henry his only next of kin him surviving.

2. Said Patrick Henry Senior died on or about the 24th day of March 1930 Intestate leaving Catherine Henry his lawful widow and nine lawful children namely said Bridget Henry Ellen Quinn Michael Henry Thomas Henry Maria Fleming John Henry Patrick Henry Junior James Henry and Walter Henry his only next of kin him surviving.

3. Said Catherine Henry widow of said Patrick Henry Senior deceased died on or about the day of March 1941 Intestate without having remarried leaving eight lawful children of said Patrick Henry deceased namely said Bridget Henry Ellen Quinn Michael Henry Thomas Henry Maria Fleming John Henry Patrick Henry Junior and Walter Henry her only next of kin her surviving.

4. Letters of Administration of the Personal estate of said Patrick Henry Senior deceased were on the 17th day of April, 1942 granted to Michael J. O'Hara of Ballina in the County of Mayo Solicitor the Attorney lawfully appointed of the said Bridget Henry.

5. Said Maria Fleming daughter of said Patrick Henry Senior died on the 28th day of August 1947 a widow Intestate, leaving six lawful children namely said James Fleming Walter Fleming Catherine Fleming Anne Fleming Joseph Fleming and John Fleming her only next of kin her surviving.

6. Said John Henry died on or about the 1st day of September, 1945 Intestate leaving his widow Maria Henry and four lawful children namely said James Henry John Henry Junior Anne Henry and Mary Gleason his only next of kin him surviving.

7. Said Maria Henry died on or about the 13th day of June 1947 leaving the aforesaid four children of said John Henry deceased her only next of kin her surviving.

9. Said James Henry son of said Patrick Henry Senior the deceased died on or about the 3rd day of November 1930 Intestate leaving his widow Bridie Henry but no issue him surviving.

Said Bridget Henry Ellen Quinn Michael Henry Thomas Henry James Fleming Walter Fleming Catherine Fleming Anne Fleming Joseph Fleming John Fleming James Henry John Henry Junior Anne Henry Mary Gleason Catherine Tower Mary Nelson Cecilia Sheehan Walter Henry Junior Joseph Henry and said Bridie Henry and each of them have agreed by way of Family Settlement to transfer and assign all their his and her share and interest in said lands comprised in said Folio 12358 of the Register County of Sligo and in the assets personal estate and effects of said Patrick Henry Senior the deceased to said Walter Henry Senior in the manner hereinafter appearing.
